Confirmation of how long as the Kaikoura District Council been aware of the wastewater issues with the Peketa Beach land, which Ngai Tahu references as reason for the lease non-renewal.

Correspondence District Council has had with landowners Ngai Tahu, regarding said wastewater infrastructure. I have had correspondence with the Ngai Tahu natural environment team, not with Ngai Tahu as landowners. See attached email.

Kaikōura District Council does not have any knowledge of this.
