Council will arrange for the physical work to be undertaken and you will be invoiced for the actual cost of the work. The Service Approval fee and Rural Water Supply charge, if applicable, is to be paid at the time of application.

In addition to the fees associated with the application and connection to the service there are annual rates charges per water unit for rural supplies and annual charges for the urban supplies and connection to the sewer system. Please contact the Rates Officer if you would like to find out about changes to your rates.
