Thank you for your thorough examination and presentation of all the options.

Our suggestion is to:

Continue user pays for rubbish. The current system of \$3 a bag has been so appreciated. If this were to continue it would make rubbish disposal within the means of all. Not having to supply wheelie bins and reducing recycling collections as set out would allow for this continuing price. It also means that you pay for what you dispose of so encouraging minimization of waste – so achieving the goals of the plan. If people find it difficult to get to the dump, I am sure that neighbours and others would assist; this could be encouraged by council. Increasing rates by up to \$100 is far in excess of the cost currently paid by those of us who have 1 bag of rubbish per month. If the collection were to be carried out with wheelie bins then this would encourage more waste rather than less.

Subject: Environment Canterbury(Contaminated Land and Waste Team) staff level comments on the KDC

Kia ora Dave,

Please see the high-level feedback from below from me. This is not feedback from the wider management or elected members. Unfortunately, due to the Christmas break and leave I did not see the consultation when it was put out on the 23 December and apologise for the delayed reply. In the future, I would hope to get wider views from within Environment Canterbury.

- It is good to see the target of reducing waste to landfill at <380kg per person per year down from the current figure of 440kg. I would like to see more detail on the plans to work collaboratively with the community to influence waste minimisation. Will there be a portion of the increased waste levy set aside for this? I see that you contract out education services. It would like to see support from KDC to encourage participation in the Enviroschools programme.
- While there is no appetite for a waste minimisation bylaw, I would welcome KDC's participation in any discussion with other TAs on the value of a future bylaw and consistency between districts in waste related rules.
- I note the difficulty in getting waste data from private companies and this is a problem shared across Canterbury. I would welcome KDC to join the regional waste data project being led by Environment Canterbury.
- Provide highlighted text to make it clear to the reader that the detail is in the Waste Assessment including proposed actions. This point is lost in the main text of the WMMP.
- It is good to see the commitment to work with product stewardship schemes and ensure they are set up to take items from the district. However, it is noted that KDC was the only district to not take advantage of the Environment Canterbury funded Agrecovery events held in November last year. This event included collection of both agrichemicals and seed and feed bags.
- I note the proposed reduction in rural recycling centres and that there could be a gap from when these cease and the regulated product stewardship scheme via Agrecovery/Plasback is in place (currently voluntary). Rural waste disposal in particular burning of farm plastics continues to be a concern for Environment Canterbury.
- The Waste Assessment identifies relevant Climate Change legislation but it is not clear that climate change has been considered and the link between this document and other KDC climate change policy/initiatives.
