- Kerb and channel clearance – West End's kerb and channels are being cleared twice a week. Council staff have asked Downer to also focus the rest of the town.
- Waka Kotahi have confirmed that more comprehensive repairs are required on SH1 outside Continental Seafood.

runoff. Council staff will endeavor to engage with the upper property owner. However, their cooperation will be required for any works to be undertaken on their property and potentially funded by the property owner.

Resourcing staff has been challenging. A Technical Services Manager to replace S Murphy is anticipated to start on 1<sup>st</sup> September. External resource support will be considered if required.


