- You need to make sure you can confirm that the operator of the food business is a resident in New Zealand within the meaning of section YD 1 or YD 2 (excluding section YD 2(2)) of the Income Tax Act 2007.
- Details for payment of your application fee will be invoiced accordingly.

Collection of Personal Information
